8. Criteria for awarding the contract : the lowest bid

10. The method of bid submission and the deadline for submission of bids : Bids shall be prepared and submitted in accordance with the tender documents and invitation to tender . Bidder submits a bid directly at the reception desk or by registered mail to the following address : City of Belgrade Belgrade City Administration , Secretariat for Transport - Directorate for Public Transport , ul. 27 March br . 43-45 - Scriptorium , counter no. 9 and 10 , 11000 Belgrade.

Bids are submitted in a sealed envelope or box, so that when the opening of tenders be determined with certainty that the first opening, certified seal, marked "Bid for public procurement no. 8/16, Carriage of passengers in public urban and local transport in Belgrade by lots (with a number of parties / for which / e bid is submitted) - DO NOT OPEN ". On the back of envelopes or boxes, the owner name of the bidder, the exact address, contact person and phone. In case the bid is submitted by a group of bidders, it is necessary to indicate on the envelope that it is a group of bidders and list the names and addresses of all participants in a joint bid. The offer shall be valid for 45 (forty five) days after the bid opening.

The offer is considered timely if received by the Purchaser to 19/04/2016 . until 12:00 hours.

11. Place, time and method of opening of tenders : Public opening of bids will be 19.04.2016.godine at 12:30 am in the premises of the Secretariat of Transport - Directorate for Public Transport , ul. 27 March br . 43-45 , Belgrade .

12. The conditions under which representatives of the bidders may participate in the tender opening procedure : Opening of bids may be attended by all interested parties and can actively participate only authorized representatives of the bidders. Authorization for participation in the bid opening shall be issued by the original bidder, a filing with the number under which it was issued , the date of issue, the stamp and signature of the person responsible bidder and submitted to the President of the Commission for public procurement immediately before the bid opening procedure .

13. Deadline for decision : The Employer shall make a decision within 25 days of the bid opening .
